The commission members decided on the next meeting date of February 24, 2017 at 10:00 a.m.

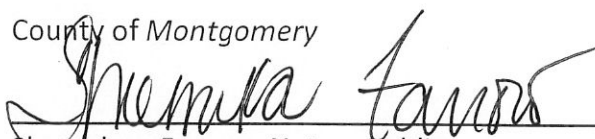
Motion was made to adjourn at 10:18 a.m. and seconded. All approved.
