Oath of Office was administered by Representative Williams for Tiffini Grimes.

Chairman Williams asked the commission members to review the renewing agent's names. He called for a motion to approve the renewing agents as a group and the motion was seconded and all approved.



Motion was made to adjourn at 10:22 a.m. and seconded. All approved.


