In order to receive your Commission Certificate as required by state law, you must file your original Oath of Office with the Office of the Secretary of State.

The County Probate Judge must certify to the Secretary of State's office that you were duly elected/re-elected for a four year term, and that you have filed your oath and bond as required by state law. There is a five dollar (\$5.00) commission fee required.

Requirements for Commission Certificate:

- 1. Original Oath of Office**
- 2. Original SOS-C-Form-1 (verification of election, bond, and oath, which should be signed by the presiding Probate Judge and his/her signature notarized).**
- 3. \$5.00 Commission Fee (Please make checks or money orders payable to Secretary of State).**
