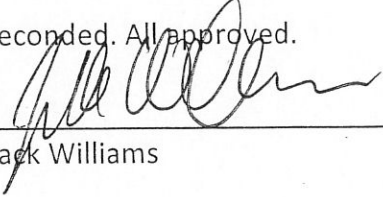

The commission members decided on the next meeting date of November 9, 2016 at 10:00 a.m.

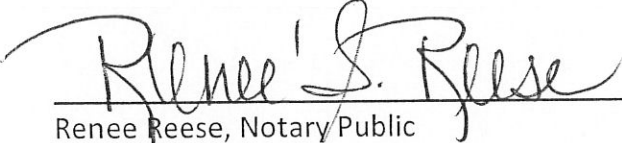
Motion was made to adjourn at 10:19 a.m. and seconded. All approved.
