The Secretary of State is hosting training for all registrars to discuss the new items and will also do a training at the Alabama Association of Boards of Registrars Meeting in September.

Adonis Whitlow said there was an issue in gaining new registrars in the state because of the low pay. She asked if there was a way for the pay to be increased especially because of the skills registrars need to be able to do for the job. There was discussion amongst the members about the bill from last session that included a pay increase. Candace Payne asked if the (AABOR) could keep her posted about the next legislative committee meeting so she can hear concerns. Dr. Benjamin Jones suggested each county registrars' office invite their legislative delegation to their office for a Legislative Day in order for the legislators to see what the registrars do on a typical day and to get to know them.

James Taylor asked about parking for the members and Candace Payne said she will check with the Archives Department. Laney Rawls also mentioned possibly parking in spaces in front of the archives when the legislators are not in session.
